**DFC Coordinator’s Report & Budget Overview**

- No Cost Extension - to allow Champions to continue using remaining funds that we have (in case we do not get DFC Funding Years 6-10 from grant submitted in April)
- Budget - no budget overview for June (only expenses were Launi’s salary)
- July - money spent on back to school events supplies, retreat, travel, etc.

**Old Business**

- 501c3 banking update
  - Bank analysis was performed.
  - The executive committee met and agreed to go with Heritage.
  - By-law revisions were made (election process details)
  - Operating agreement (Similar to the by-laws except that the names of those in executive committee define who is allowed to do what)
  - Paperwork to be completed for Heritage to finalize
- Marijuana legislation
  - Champions released a Delta 8 / Marijuana update given to elected officials + community.
  - Federal level - legislation trying to have marijuana legalized but states would still have the option to choose to legalize or not.
    - OHIO - Pushing to legalize recreationally. It is already legalized medicinally (fairly strict policy). This is supported by the Mayor of Cincy.
  - Delta 8 - illegal at federal level so illegal at state level.
    - Four businesses in Grant county were selling Delta 8 at time of last environmental scan

- Prevention First - Talking points being created if you want to do advocacy against marijuana legalization. Send to **Amanda Conn Starter any data / contacts by groups that border OH that might be willing to show how legalization would impact them** (OH residents crossing over into KY, IN).
- Suggested to look at research from Tom Gorman @ Rocky mountain HIDTA (Lawsuits from surrounding states for increase in social services. Increase in homelessness, cost of social services, etc.)
- Snapchat Awareness Campaign:
  - Found that youth knew they could purchase things from Snapchat from our Core Measures survey (replaced KIP)
  - Starts TODAY (8/2/2021) and through early September
  - Using #socialmediamonday
  - Aimed at Parents - Focuses on the risks that Snapchat poses regarding substances like vapes/marijuana, heroin, and other illicit drugs
