Alcohol SB 67

- businesses can sell alcohol to-go permanently
- "Alcohol: Keep a Lid on It" Statewide prevention Similar to Sticker Shock that prevention messaging will be added to the to-go containers.
- Belle's has agreed to participate.

Tobacco SB 56

- No longer a "status offense"
- KRS 438.050 School boards can not fine less than \$1, more than \$5

Majiuana H.R. 1996 and S.910

- SAFE Banking Act
- allow banks to accept the federally illegal proceeds from the sale of marijuana
- Can vote NO on the SAFE Banking Act
