- Marijuana Dry Ridge vape shop advertising "Cake 2 for \$15". Cake is a THC vape brand typically sold at \$34.99 each
 - Same vape shop said they will continue to sell non-FDA approved vapes (despite HB 11 going into effect January 1) until they are told not too (i.e. until enforced)
- Other Williamstown City Councilmember has suggested revoking Smoke-Free Air Ordinance

National

- Marijuana Door Dash to start delivering marijuana products to *eligible* customers; coalition is curious how eligibility will be determined
- Other FDA authorizing ZYN nicotine pouch products is significant considering Youth Focus Group results (see full report)

Observations

While responses such as advertisements at gas stations and vape shops, type of products like "pretty" and "fruity" alcoholic beverages, and common places for use/access points such as "fields", home/friend's homes, fake I.D.s, older siblings, school bathroom, etc. are common among youth, students identified the following concerns unique to Grant County:

- Have heard of other students passing out alcohol in student parking lot to consume elsewhere
- Two gas stations in Dry Ridge that are known for not checking I.D.s
- That non-Caucasian workers, specifically, do not check I.D.s
- Smoking 'pot' at Piddle Park
- Notable increase in advertisement of and use of Zyn pouches
- Notable lack of responses to questions around opioids and stimulants

Students were also asked about social media platforms that display substance use and specific trends involving substance use that they see on social media. Although 99% of students stated that they see substance use the most on Snapchat, the trends they discussed (described below) are primarily found on TikTok.

Social Media Trends



"Snorkeling"

Putting a wine bottle into a can then shotgun the whole bottle and the can

Coned

Consuming edibles that look like small ice cream cones in large amounts before activities (i.e. ordering food in a restaurant while high, flying while high)

"Get Ready With Me"

Playing off the popularity of makeup tutorials but hitting a dab pen between every makeup step



Flared Money

Displaying a vape in the middle of flared money from vape sales

Drinking

Common to post photos and videos of drinking on Snap stories rather than individual messages
